Battle Treaty

Contracts without the signature of the organizer are invalid. Two copies must be submitted to the BDF within one week of completion. Each contract must be issued four times.

Between..... recognized as an organizer within the framework of the provisions of the BDF and the boxer

..... Represented by the manager closed:

1. The organizer obliges the signing boxer to a boxing match according to the "Sporting Rules" of the BDF on in.....

at..... Watch, with a weight ofkg.

As an opponent is or an equivalent substitute with a weight of kg.

The fight is scheduled for Rounds of 3 minutes each with a break of 1 minute between rounds. The weight of the gloves is Ounces.

The organizer and manager should agree on the equivalence of the substitute.

2. The boxer Fight at your own risk and is obliged to fight under the conditions specified in the contract. The boxer declares that he/she will fight in the best physical condition and has no infirmities or physical disabilities to hide.

The boxer receives as a fixed battle exchange

Furthermore, the organizer undertakes to continue to cover the costs:

- Position of Overnight stay(s) for Persons

1. Fare for km to 0,30 €/km each, or
 - Air travel from after..... Return flight to für Pers.
1. Call money for Days in the amount of EUR/day.

The contracting parties declare by their signature that no further remuneration has been agreed. If one of the boxers does not bring the agreed weight, he has to pay his opponent If both boxers do not bring the agreed weight, the penalties to be paid will then be forfeited to the BDF (only for championship fights).

3. The organizer undertakes to pay out 50% of the fight exchange to the parties before the fight. Should the fight be completed taking into account point 4 of this contract, the remaining 50% of the agreed exchanges will be due immediately after the fight.

All other agreed costs such as e.B. call money, fare or similar will be paid by the organizer immediately after arrival at the venue or hotel.

4. In the following cases, the delegate of the day of struggle has the right to withhold the second 50% of the fight exchange:

in an obvious mock fight

in case of termination of the fight by the referee due to lack of fighting ability of the signing boxer

when the fight is abandoned without a valid reason

if the fight is abandoned due to alleged injury (the decision as to whether the injury is valid is made by the acting doctor)

in case of disqualification by the court martial

in the event of inability to carry out the fight, determined by the court martial within the meaning of §2 of the "sporting rules" of the BDF

The BDF Executive Board is responsible for deciding on the retained stock exchange in the first instance. The board of the BDF can release the stock exchange or declare it forfeited.

In the latter case, the stock exchange must be declared forfeited depending on the seriousness of the misconduct - at most 50% and at least 25%.

The stock exchange for expired flows to the cash register of the BDF.

5. In the event of culpable non-performance of this contract, both contracting parties may agree on a contractual penalty without prejudice to the claim for damages.

In all other cases, contractual penalties are not permitted.

Unilateral contractual conditions and contractual penalties are prohibited.

6. If, for reasons of force majeure or in the event of an injury or illness attested by a trusted doctor, or in the event of a main fighter's non-appearance, a postponement of the day of the fight is necessary, the fight will be scheduled for a later date, which does not take place after the may lie.

The boxer undertakes to, from the date of not to box elsewhere until the day the fight is held.

7. A change of a sporting nature occurring between the date of signing and the fulfilment of this contract (loss of a fight or loss of title) or a suspension of a contractual partner pronounced by the BDF grants a right of withdrawal from this contract. Withdrawal must be made in writing. Any claims from this can then not be derived from any of the contracting parties.

8. In order to determine a weight, the boxer is obliged to act in the presence of the organizer and the weighing commission on in..... at..... Clock to go on the scales.

The medical examination takes place around Clock in the cradle restaurant.

The boxer has Be at the battle site hours before the start of the event and move into your assigned locker room.

9. Verbal or telephone agreements are not valid. All other agreements concerning this fight and not specified in the contract, which, however, may under no circumstances contradict the "sporting rules" of the BDF, must be concluded under point 12 "Special agreements" or in an additional contract.

10. The organizer declares that he is liable for damages of the boxer caused by an irregular ring. The event is under the supervision of the BDF. The court martial, timekeepers, doctors and the delegate are determined by the BDF. All trainers/seconds must be licensed. The organizer assumes no liability for the storage of valuables of any kind.

11. In all disputes arising from this contract, the contracting parties submit to the institutions and provisions of the statutes of the BDF as well as to the "sporting rules".

The boxer declares his/her fundamental willingness to carry out a possible doping investigation.

The place of jurisdiction for both parties is the district court or regional court Halle-Saale.
