## **MANAGER CONTRACT**

(in three copies, each for the manager, boxer and the Bund Deutscher Faustkämpfer)

§ 1 The boxer undertakes, starting with the .....

for a period of ...... years (not longer than 5 years possible)

To provide services for boxing and show matches, training demonstrations and other obligations that are generally considered beneficial to the boxer.

This obligation applies to Germany and abroad.

An employment relationship is not established by this obligation.

§ 2 The Manager undertakes to direct all his efforts to the

To provide boxers with rewarding fights and other professional earning opportunities.

He assures the boxer of professional training, has to take care of training matters (ordinary training) and secondaries and to assist the boxer with words and deeds.

§ 3 The boxer undertakes, for the duration of this contract, to refrain from any professional practice without the consent of the manager.

This also includes the exploitation of his name.

- § 4 The boxer must submit to the training regulations of the manager and lead a sporty impeccable life in order to be able to fulfill the contract concluded by his manager according to his best ability.
- § 5 The Manager concludes and signs the contracts; he alone has the right to receive stock exchanges, fees and other fees and to acknowledge them.

Series fight contracts, extensive options (for more than three fights) as well as contracts for title fights must also be signed by the boxer.

The manager receives ...... from the hundred of all funds that go to the boxer from fights, show fights, training demonstrations and similar obligations.

From other income, e.g. from film, television and broadcasting rights, etc., the manager receives .... percent.

In the same way, the manager is to participate in fees of the boxer for the surrender of his name for advertising purposes of any kind. The calculation of the share attributable to the manager is based on the boxer's service.

(Manager percentages must not exceed 33.3%)

Only the following are deductible:

- 1. Travel expenses for boxer, manager and possibly trainer to the place of fight and subsistence costs
- 2. Extraordinary training expenses, if these are not paid by the organizer (fees for sparring partners, training camp, etc.)
- 3. Extraordinary expenses to obtain worthwhile earning opportunities

The manager is obliged to hand over a proper written statement to the boxer immediately after each fight has been performed.

If the commitment of a special interest representative appears necessary in foreign matches, half of his remuneration is to be borne by the manager and half by the boxer.

| § 6 Changes to the form of government or reorganization or renaming of the boxing association do not cancel this contract.   |  |  |

| § 7 If the manager does not carry out the training of the boxer himself, he must hire a trainer and pay for this from his manager's share.   |  |  |

| § 8 In the event of the absence or inability of the manager, the latter must, in agreement with the boxer, instruct a licensed manager to comply with his contractual obligations or authorize the boxer himself to safeguard the business. If it is clear that the absence or prevention lasts longer than six months, the boxer has the right to withdraw from this contract. The same applies if the representation lasts longer than six months. |  |  |
| § 9 Additions or changes to this contract must be concluded in writing before the BDF or its agents as a contract supplement on the back of this contract in order to be valid. If this contract is not terminated in writing under "registered mail" three months before expiry, it shall be deemed to have been terminated at years extended. (Extension not longer than 1 year possible)  |  |  |
| § 10 The legally valid signature under this contract must be confirmed by both partners at the same time before the BDF or its representatives.  |  |  |
| § 11 Manager contracts can only be concluded with the BDF-licensed manager become.   |  |  |
| § 12 The contracting parties submit in all disputes arising from this contract the facilities and provisions of the statutes of the BDF and the "Sporting Rules" of the BDF.   |  |  |
